Katie began working with striated caracara in 2015 and now leads an international conservation research program focused on their long-term monitoring, understanding the species' basic needs, and positively changing global perceptions of this unusual and rare bird of prey.

Katie's work on Saunders Island is yielding some exciting results, both for the species and the Falklands. My project is to document her work in a 30 minute film, showing in detail, the birds, her methods and the exciting findings.

Each of the studied birds is tagged, so she is also recording personality traits, characteristics, and how these affect results. There is real character to the science.

Katie is a very enthusiastic proponent for the Caracaras. She presents information in an informative, engaging and entertaining way. My intention is to spent 4 weeks documenting the Caracara experiments and all of the above in a film.

The Caracara global population, including those on the southern fringes of South America, is estimated at 1500 adults, and only recently have they gotten the attention of researchers. Trying to learn what this remarkable species needs to survive and just how they do it is the objective of the studies.

The object of the film is to show the studies, the unique characters of the birds, present the results and rebrand the "Flying Devils" as national treasures.

The Caracaras should be considered in amongst the most intelligent birds in the world, success for this project will be a completed film, artfully telling the caracara story to a wide audience. Viewing figures for the film will be the main metric for the project.

Then in the edit, establishing a narrative, characters and weaving together a coherent story. Oly has reduced his day rate from (editing) to for this project. Although the shooting window is set at 28 days, Oly is able to continue to film throughout the year and intends to do so (various locations). The edit timeline is 90 days, this is flexible and will involve re-edits to suit possible transmissions.
