During this period I designed a yacht charter specification for the planned 2019 surveys, and have now published an invitation to quote for this charter which is open until the 8th November 2017.

I have gathered quotes for equipment for the 2019 yacht cruise which has a long lead time, and have begun the purchasing process. All should be on order by the end of December 2017.

During May/June we made significant changes to the project contents including some changes to the objectives, in order to increase the scope of the project in view of the additional funds provided by EU BEST towards a component of this project. This led to some changes in terms of budgetary distribution between financial years and an extension of the end of the project timetable by three months, to the end of December 2019. These changes are intended to enhance the project since with the extra funds we have been able to include the goal of conducting a population recovery assessment for the South Georgia right whales, and conduct an in-depth assessment of past exploitation levels.
