The acoustic monitoring equipment purchased has had to vary slightly from the initial plan. This is due to a necessary change in deployment and retrieval methods for the equipment from

divers (original method) to acoustic release. This should not affect the project budget or equipment budget line.

Obtaining the changed acoustic monitoring equipment from around the world has been longer than anticipated. This will delay deployment of the devices from Q2 (September 2018) to Q3 (November 2018). This should have no significant consequence for the project (output 4.1, 4.2 and 4.3).

The delays have come to light and have been attempted to be resolved over the last two weeks; however a slight (but not significant) delay to the timetable is inevitable, this will have no knock-on effects to the Outputs, Outcome or Budget.
