Progress on activities:

1.1 - Delayed

- We successfully recruited a Net Camera Specialist.
- However, the recruitment of a Project Manager was delayed due to a lack of suitably qualified applicants. Despite initiating recruitment in June, it has taken 5 months to recruit a Project Manager. Although recruitment can often be challenging for OTs, this was unprecedented and has led to a delay in the start of the project. We are pleased that the most recent recruitment round for the Project Manager was successful, and we are negotiating terms and start dates.

1.2 - On track

- We worked closely with our project partner, DNR-Fisheries, to understand what the requirements were for net cameras. We identified several key features that would be advantageous in particular the ability to program and download data without having to remove the camera from the net, or open the camera housing. Based on these requirements, we identified several potential net camera systems, which were all similar in price. However, only one of the camera systems had been thoroughly tested in other fisheries. The net cameras have now been built and are in the process of being shipped to the Falkland Islands.
- We will trial the net cameras early in the New Year, during the DNR-Fisheries recruitment surveys.

3.1 – On track

• Working closely with our project partner, DNR Fisheries, we have identified a list of variables and are in the process of accessing these.

5.1 – Delayed

- While the PMG meeting has been delayed until we recruit a project manager, we have been in regular contact with PMG members individually, updating them on project progress, and in the case of the Net Camera Specialist, have involved them on the recruitment panel.

 - Despite initiating recruitment in June, it has taken 5 months to recruit a project manager. Although recruitment can often be challenging for OTs, this was unprecedented and has led to a delay in the start of the project.
 - There is little we could have done to offset this delay, as we advertised shortly after we were notified of the outcome of the project (after requesting permission to do so from Darwin). We are pleased to report that last round of recruitment for a Project Manager was successful.

At this stage, we do not expect this to affect the log frame and delivery, but it does have financial implications that will necessitate a change request, which is currently being prepared.
