Section 4 - Aims, Activities & Achivements

Q10. Describe briefly the aims, activities and achievements of the proposed Fellow's employing organisation.

The University of Gibraltar (UoG) is dedicated to meeting societal needs, fostering personal and professional growth through education, training, and research. Central to its mission are partnerships with local and global entities: businesses, government bodies, charitable foundations, healthcare providers, and educational institutions.

The UoG also supports conservation projects that contribute to the protection of the local natural environment. The University is currently leading two Darwin Plus Local awards, including DPL00044, focused on assessing biodiversity in Windmill Hill Flats, and DPL00057, centred around oyster restoration in British Gibraltar Territorial Waters.

Lillianne will collaborate with Prof Julia E. Fa, with whom she works on DPL00044, coordinating environmental surveys for habitat restoration and wildlife management. Lillianne will be employed by the UoG, enabling her to extend her 10-month contract. This employment will involve fulfilling the fellowship requirements and the opportunity to enrol on a Master's programme, to further her studies.

Q11. Describe briefly the proposed Fellow's current role within their organisation and what relevance this has to one or more of the main themes of Darwin Plus.

Lillianne's current position in project DPL000444 is closely aligned with the core themes of the Darwin Plus:

Biodiversity: Lillianne currently coordinates field activities in this project. Its primary objective is to formulate management strategies and sustainable approaches for the long-term protection of important biodiversity areas in Gibraltar. This project will generate management plans that guide the protection of plants and animals unique to the target areas as well as mitigate the adverse effects of invasive species and uncontrolled anthropogenic threats and examine the potential for reintroducing lost species.

Capability and Capacity Building: Lillianne is also responsible for the development of local expertise by training environmental and conservation officers in survey techniques. She also facilitates collaborations with all local stakeholders and, with the backing of the project leader and host institution, explores opportunities for environmental education at the community level. This includes involving local schools in fieldwork and promoting research projects in partnership with the UoG. She has fostered valuable working relationships with key local organisations and individuals, some of whom are affiliated with DESCCH. Her prior experience collaborating with Mr. Mark Pizarro on macaque management also equips her to achieve immediate progress in this fellowship.

Section 5 - Outcomes & Objectives

Q12a. A clear outline of the aim and objectives of the Fellowship

The main aim of the fellowship is to address critical gaps in information on the Barbary macaque population in Gibraltar.

Its objectives are:

1. Census all animals in the current macaque population

• Employing non-invasive, cost-effective data collection methods to document all monkeys in each troop, creating an extensive library of photographs and descriptions for each resident animal.

2. Improving information by establishing a comprehensive computerised database, incorporating baseline records, for managing Gibraltar's macaque population

This will be achieved by:

• Defining the database's scope and structure.

• Collaborating with experts experienced in database management.

• Collating existing data and implementing new data entry procedures for:

I. Individual Identification Data: Including unique identifiers, physical characteristics, and genetic information; II. Demographic Information: Age, birth date, gender, troop affiliation, and parentage;

III. Health and Medical Records: Health assessments, vaccination history, veterinary records, post-mortems (including cause of death);

IV. Data Sources and References: Document data sources, including research studies, field reports, and past monitoring programmes;

V. User Access and Security: Determine user access controls, alongside robust backup and data recovery procedures.

3. Evaluate human-macaque conflict:

Human-barbary macaque conflict in Gibraltar revolves around feeding, property damage, tourism impact, territorial behaviour, associated with managing the monkeys within a highly human populated territory. Data on these issues will be gathered on documented conflicts between residents, tourists, and macaques by:

I. Compiling data on tourist bite incidents from Gibraltar General Hospital records;

II. Documenting incidents of macaques entering properties or causing damage based on Gibraltar police reports; III. Assessing troop home ranges, movement patterns, and their overlap with residential areas;

IV. Evaluating the effectiveness of existing methods aimed at discouraging macaques from venturing into human-populated areas.

4. Foster support within the local community through outreach initiatives to improve awareness and understanding

Q12b. The role of the applicant and/or host organisation, and others where relevant

The applicant, Prof Julia Fa, offers experience from previous Darwin projects which will feed into Lillianne Hawkin's fellowship. She will act as main advisor and point of contact throughout. Julia's expertise enables her to offer comprehensive guidance and support to Lillianne, as well as facilitating close collaboration with DESCCH and the valuable assistance of local experts such as Veterinarian Mark Pizarro (Head of the Macaque Management team) and Ms. Bethany Gadd (PhD Researcher and Associate Lecturer for the MSc Environmental Science and Climate Change Programme at the University of Gibraltar). Dr Sylvain Lemoine will assist in complementing the population monitoring and data collection through the Gibraltar Macaques Project, hosted by the University of Cambridge.

The host organisation, the UoG, will serve as the lead partner for this fellowship. Facilitating the development of local capabilities and capacity, ensuring that Lillianne acquires the necessary skills, knowledge, and resources to address local environmental challenges. The University will also support her in engaging with local stakeholders

through a public outreach campaign. Importantly, this project aligns seamlessly with the University's MSc in Environmental Science and Climate Change and will therefore enable the participation of students in monitoring projects.

Under the UoG and DESCCH, Lillianne will be responsible for conducting fieldwork and desk work in line with the objectives of this fellowship. The DESCCH will host and ensure the maintenance of the macaque database and guide the application of conservation protocols via the Macaque Management team. To promote accessibility and transparency, the database will be subject to discussion with DESCCH and stakeholders, serving as a crucial resource for informing enforcement frameworks to maintain the health of macaque troops.

Q12c. Where appropriate, how the Fellowship will contribute towards one or more of the four themes of Darwin Plus in the OTs i.e. what the expected outcome of the Fellowship will be.

This relevant and necessary fellowship contributes primarily to two of the Darwin Plus themes: Capability and capacity building: This fellowship application is the first known to be submitted by a Gibraltarian British national, from an organisation in Gibraltar, for a Gibraltar-based project. The fellowship will provide training opportunities for Lillianne, including visits to reference centres in the UK (Trentham Monkey Forest) and London Zoo. These visits will allow Lillianne to learn from experts, enhancing her knowledge and understanding of monitoring and managing macaques.

Lillianne will disseminate knowledge gained through a formal report for DESCCH, and a presentation with accessible handouts for the Macaque Management team. Additionally, Lillianne will apply this knowledge to develop a fit-for-purpose database and additional training to keep the Macaque Management Team up to date on the new knowledge gained. Lillianne will provide seminars for schools at the Tovey Cottage Natural History Field Centre for environmental education, engaging local stakeholders and providing a framework to give feedback to the community.

Biodiversity: The outcome of the fellowship will be a database of the Gibraltar macaque population, to inform conservation and management policies on an iconic species for Gibraltar, to ensure its continuation as a sustainable tourist attraction. The information gathered and the database created during this fellowship will provide a robust baseline for which future information gathered can be compared, subsequently informing HM Government and influencing policies and directives. It shall also be shared with the International Primatological Society (IPS) and Primate Society of Great Britain (PSGB) to begin a current and continued synergy.

Section 6 - Legacy & Collaboration

Q13. Legacy

Provide information on how the Fellow will utilise, promote and disseminate the benefits of the Fellowship. Will a strategy be developed during the Fellowship to ensure this is achieved?

The Macaque database will facilitate the identification of individuals, improving the conservation and management strategies of troops, and ensuring their long-term well-being. Developed during the fellowship, the monitoring programmes will integrate into the broader macaque monitoring effort, facilitated by close collaboration with the Macaque Management team.

The UoG, with the continued collaboration with DESCCH, will provide sustained support with the MSc Environmental Science students contributing to the database. Following this fellowship Lillianne plans to continue to work on the database, ensuring it remains current and relevant.

Lillianne will benefit from training trips, sharing gained knowledge through outreach seminars at the University

and educational talks to school groups at Tovey Cottage. The project's results will be disseminated through peerreviewed publications and articles intended for a broader audience.

The UoG's marketing team, after consultation with DESCCH, will oversee the project's communication efforts, producing various communication outputs aimed at garnering community support, including two articles for the local newspaper, The Gibraltar Chronicle, segments for broadcasting on the local TV channel, social media posts, and posters to distribute within the Upper Rock section of the Gibraltar Nature Reserve.

Q14. Priorities

How will the Fellowship assist the OT's environmental priorities? Please refer to international or national environmental conventions, treaties, agreements, strategies and/or action plans relevant to the OT as appropriate.

The project supports:

(1) The Gibraltar Biodiversity Action Plan, Section 3: Provision of long-term protection for species and habitats, including the Upper Rock as terrestrial nature reserve.

(2) The Gibraltar Nature Reserve (GNR) Management Plan, which places emphasis on fauna found nowhere else in Europe: the Barbary macaque.

(3) The Barbary Macaque Action and Management Plan, which includes, among others: Monitoring of the population; Improving communication to the public; Maximising the use of the macaques as an educational resource.

(4) Upper Rock Management and Action Plan, Section 14 which outlines macaque population control methods such as relocation, contraception and routine management to prevent inbreeding problems and favour healthy genetic variability.

Internationally:

(5) Convention on Biological Diversity (CBD), Article 8(d): Promote the protection of ecosystems, natural habitats and the maintenance of viable populations of species in natural surroundings; Article 8(i): Endeavour to provide the conditions needed for compatibility between present uses and the conservation of biological diversity and the sustainable use of its components.

(6) Bern Convention, Article 2: Maintain the population of wild fauna at a level which corresponds in particular to ecological, scientific and cultural requirements, while taking account of economic and recreational requirements.

Q15. Collaboration

What collaboration has there been with the proposed Fellow to date in developing the proposal, and what collaboration is planned for the duration of the Fellowship? Where relevant, describe any consultation or collaboration by the proposed Fellow within their own territory.

This proposal has been drafted collaboratively by Lillianne Hawkins, the Project Lead Prof Julia Fa and the University of Gibraltar. Lillianne has consulted the DESCCH at the preparation stage of this project to obtain the relevant site access and work permits. Collaboration is planned with the following experts:

- Mr Mark Pizarro, Chief Veterinarian, Gibraltar Veterinary Clinic. Mark is contracted by the DESCCH as Head of

the Macaque Management Team.

- Ms Bethany Gadd, lecturer at the UoG is currently working on her PhD on complementary topics of the biology and behaviour of the Gibraltar macaques.

- Dr Sylvain Lemoine, University of Cambridge, will assist the Fellow in identifying individual monkeys, profiling and monitoring; in gathering behavioural and human-macaque interaction data. The baseline information gathered within this fellowship will also support the research objectives of Dr Lemoine's Gibraltar Macaques Project.

Lillianne has engaged with the two-times Darwin fellow Jakovos Demetriou, who visited Gibraltar in 2023 for a Darwin Plus project on invasive species, led by Prof Helen Roy (UK Centre for Ecology & Hydrology).

Q16. Where will the Fellow be based?

Lillianne will implement her fellowship programme in Gibraltar.

For computer-based work and statistical analyses she will be based at the University of Gibraltar, where she has an office space for the DPL00044 project. Fieldwork will be carried out at the Gibraltar Upper Rock Nature Reserve, in collaboration with the Macaque Management team from DESCCH.

Tovey Cottage, an educational resource from DESCCH located at the Nature Reserve, will be used to deliver talks for schools, an activity where the fellow has relevant experience. The John Mackintosh Hall (JMH), an exhibition venue located in the centre of town, will be used for wider community outreach activities. Existing MoUs (Memorandum of Understanding, formal agreements) guarantee the use of the Tovey Cottage and JMH spaces at no extra costs.

During this fellowship, Lillianne will visit a UK zoo and the Trentham Monkey Forest (https://monkey-forest.com) to learn record-keeping procedures used by these organisations that could be implemented in the Gibraltar context.
